TYPICAL FINANCIAL AID SUCH AS PAYMENTS FOR RENT AND UTILITIES IN ARREARS, SECURITY DEPOSIT, AND MOVE-IN FEES ARE PROVIDED, ALONG WITH SHORT-TERM CASE MANAGEMENT TO ASSIST CLIENTS IN BUDGETING AND OTHER PLANNING TO ENSURE THEY ARE ABLE TO MAINTAIN THEIR HOUSING.

HEALTH STAFF WORK WITH PARTICIPANTS TO ADDRESS PHYSICAL AND BEHAVIORAL HEALTH ISSUES AND IMPROVE LONG-TERM HEALTH.
